1. Presenter

Other Music Academy e.V. is the official presenter of Yiddish Summer Weimar. Please note that workshop content and staffing may be subject to modification.

2. Registration / Workshop fee

Online registration is now open.

Registration becomes binding once the entire workshop fee has been credited to *Other Music Academy e.V.*'s account. Payment options include:

- direct debit payment via SEPA
- credit card
- Giropay
- Paydirekt
- Paypal

3. Languages of Instruction

The workshops will be taught primarily in English, German and Yiddish, according to each teacher's preference and ability. Every reasonable effort will be made to provide translations if necessary, but there is no guarantee that each teaching session will be translated into all languages spoken by all participants.

4. Daily schedule

Please refer to the specific workshop descriptions for the daily schedule. Jam sessions, concerts and other workshop activities take place in the evenings. You will get more information about how the workshop is organized in advance. Changes to the daily schedule may occur during the workshop itself. For workshops of 7 days or more, a free morning or afternoon may be inserted about halfway through.

5. Concerts (New regulations)

As a participant, you naturally have free admission to the final event of your workshop. In addition, you are entitled to free admission to <u>one</u> event of your choice held during the period of your workshop. Participants attending several workshops will receive one free ticket per workshop, each valid for one event held during the period of the respective workshop. Participants in a final concert or dance ball will receive a discounted guest ticket for that event, venue capacity permitting. We recommend that you reserve your guest ticket in advance at the info point.

For other events held during the period of your workshop, reduced tickets will be available at the Info Point while tickets last.

For events happening outside the period of your workshop, we kindly ask that you purchase a ticket (either online in advance or at the box office before the event).

There are no reserved seats, so you might be asked to cede your place to a paying audience member.

Participants also receive one discounted guest ticket for the dance ball, while tickets last. Please note that latecomers will not be admitted.

Remaining tickets will be available at the box office 30 minutes before the concert or at the *Weimar Tourist Information* office (tel. 03643-745-0). For an overview of the concerts, see our homepage www.yiddishsummer.eu.

Please note that decisions pertaining to participation in a final concert and the concert program are at the discretion of the workshop instructor.

Each participant is responsible for his/her own accommodation and food expenses. For more information, including a list of hotels, hostels and pensions we are in partnership with, see the link **"Accommodations".**

7. Important: Registration Cancellation

Registrations may be cancelled only until June 12, 2019. In such cases, Other Music Academy e.V. will refund the fee paid minus 150 €. The remaining sum will be transferred to your account within 4 weeks.

Cancellations after June 12, 2019 will not receive a refund.

For the workshops to take place, a minimum number of registrations must be received by July 1, 2019. If this number is not reached, *Other Music Academy e.V.* reserves the right to cancel the workshop. In such a case, the entire registration fee will be refunded.

We recommend that you purchase travel and seminar cancellation insurance to avoid incurring unnecessary costs if your workshop is cancelled.

8. Scholarships for course fee

Other Music Academy e.V. strives to award one or two scholarships for each workshop. These intend to make it possible for people to participate who would otherwise be unable to do so for financial reasons. Scholarships cover parts of the cost of the workshop tuition. Scholarships are given exclusively for the time period of the workshop in which the recipient is registered. Receiving a scholarship for one workshop does not entitle that participant to scholarships for any additional workshops. Anyone is eligible to apply for a scholarship. Since the scholarship is intended for participants with financial need, *Other Music Academy e.V.* requires documentary evidence of the financial situation of the applicant. In addition, please attach a short description of why you wish to attend Yiddish Summer and how a scholarship will help you. A short explanation of why you want a scholarship is also required. Scholarships are awarded according to the budget of *Other Music Academy e.V.* the financial situation of the applicant, and the order the application is received. The application must be received in the *Other Music Academy e.V.* office no later than **May 1, 2019**. A submitted scholarship application entails no legal claim to a scholarship award. The board of Other Music Academy e.V. makes all decisions concerning scholarships. Applicants will be notified by **May 15, 2019**. 9. Documentation

We will share your personal data with your workshop instructor(s) only with your consent, and only if this information is relevant to the planning and implementation of the workshop(s).

While all the above-mentioned service providers, employees and credit institutions have access to necessary personal data, they may not share or use this information for any other purpose and are contractually bound to handle it in accordance with this privacy statement and the GDPR.
